आदरणीय श्री हरीश रावत जी,

हमारे देश में जिलों के प्रभावी और समयबद्ध विकास के लिए संसद, राज्य विधान मंडलों और स्थानीय सरकारों (पंचायती राज संस्थाएं/नगर पालिका निकायों) में निर्वाचित प्रतिनिधियों के सभी स्तरों में बेहतर समन्वय स्थापित करने के उद्देश्य से सभी राज्यों/केन्द्र शासित प्रदेश को दिनांक 27 जून, 2016 को जिला समन्वय तथा निगरानी समिति (डीडीसीएमसी) गठित करने के लिए समसंख्यक आदेश जारी किया गया था। इस समिति को अब 'दिशा' कहा जाएगा।

अब यह समिति मंत्रालय द्वारा पहले से गठित जिला सतर्कता एवं निगरानी समितियों (डीवीएमसी) का अधिकांत करेगी तथा डीवीएमसी के लिए मनोनीत अध्यक्ष/सह-अध्यक्ष 'दिशा' के अध्यक्ष/सह-अध्यक्ष के रूप में भी कार्य करेंगे। ऐसी समिति के गठन के लिए दिशा-निर्देश संलग्न हैं। राज्य/केन्द्र शासित प्रदेश को तदनुसार अधिसूचना करने का भी अनुरोध किया गया है।

दिशा-निर्देशों के अनुसार 'दिशा' की बैठकें प्रत्येक तिमाही में कम से कम एक बार अर्थात् प्रत्येक वर्ष अप्रैल, जुलाई, अक्टूबर तथा फरवरी में आयोजित की जानी चाहिए। तथापि, चालू वर्ष (2016-17) के लिए इस नवसृजित समिति की पहली बैठक 13 अगस्त, 2016 को आयोजित की जाएगी। सभी राज्यों/केन्द्र शासित प्रदेश को आवश्यक अनुदेश अलग से भी जारी किए जा रहे हैं।

मुझे आशा है कि सभी जिलों में इन समितियों की पहली बैठक 13 अगस्त, 2016 को संघटित करने के लिए आप मुझे सहयोग देंगे।
